### Terms and Conditions:

- 1) A refundable deposit of \$\_\_\_\_\_ is required at the time of booking. In addition, 100% of the rental price is required at the time of booking and is non-refundable, but may be transferred to an alternate date, based on availability. Initial deposit will be returned after the event as all rules and regulations are adhered to and there is no damage to the facility. . It is understood and agreed to by both parties that the client shall be responsible for any and all damages to property, which may reasonably attributed to the group. Damages will be deducted from the initial deposit.
- 2) It is understood and agreed to by both parties that the group will abide by any and all of the Lakeside Park Association’s rules and regulations and or instructions of LPA staff personnel. Lakeside Park & Lakeside Beach Grill reserve the right to re-schedule location assignments when an emergency situation occurs that can harm a guest. Lakeside Park & Lakeside Beach Grill is not responsible for lost or stolen articles.
- 3) A California Sales Tax of 7.25% and a Service Charge of 20% shall be added to all Food and Beverage charges.
- 4) All decorations provided by the client must have prior approval of Lakeside Park & Lakeside Beach Grill. Items shall not be affixed in any manner to walls, doors, ceilings or fixtures. Tape or wire is ok to use. . Throwing of rice, birdseed, confetti or releasing helium balloons are prohibited due to possible harm to the wildlife and birds. Rose or flower petals are ok.
- 5) All printed material or advertising using Lakeside Park Association or Lakeside Beach Grill’s name and logo much have prior approval by same. Wedding invitations do not need approval.
- 6) Lakeside Beach Grill must supply all catered Food and Beverage for all functions. Outside catered food will not be allowed and no alcohol will be permitted to be brought in to a function. All Food and Beverage must be consumed on the premises and may not be taken off premises, except for cakes or special desserts.
- 7) Lakeside Park & Lakeside Beach Grill reserve the right to re-schedule location assignments when an emergency situation occurs that can harm a guest.
- 8) Persons under the age of 21 will not be allowed Alcoholic Beverages.

**Terms and Conditions, cont'd:**

9) GUARANTEE: A guaranteed Guest Count must be received 7 days prior to event. This Guaranteed Guest count will be considered the minimum for which you will be charged, even if fewer guests attend. If paying by credit card, cash or cashier's check, payment must be made 7 days prior with final count, at which time an estimated bill will be presented.

10) All functions will be subject to one master bill. Individual payments cannot be accepted.

11) Lakeside Park Association & Lakeside Beach Grill reserve the right to discontinue any music that disturbs our other guests. We ask that all music be kept to an acceptable level in consideration of all of our guests.

12) In consideration for the use of Lakeside Beach or Lakeside Beach Grill, the undersigned agrees to indemnify and defend Lakeside Park Association and Lakeside Beach Grill and its officers, employees and agents harmless from any and all claims, demands, causes of action or liabilities, arising out of injuries to or the death of any person. Also to include injury or damage to any property arising from the use of such property.

13) Horse drawn carriages or horses with out carriage must have a diaper on to avoid unsightly occasions. Any horse not wearing a diaper, the client will be charged a \$200 cleanup fee.

14) Parties with less than 25 guests may be charged a labor fee per attached Event Order, unless otherwise specified.

15) Delivery times for cakes and fresh flowers are to be a maximum of 1 hour prior to the event. We are not responsible for any delays in the delivery of said items.

16) I hereby grant to Lakeside Beach Grill the irrevocable and unrestricted right to use and publish photographs of me, my wedding, or in which I may be included, for Bridal publications, electronic reproductions (web sites) and/or promotional materials or any other purpose and in any manner or medium. In addition, I grant my permission to alter the same without restriction; and to copyright the same. I hereby release the photographer and Lakeside Beach Grill from all claims and liability relating to said photographs.
